FACTS YOU SHOULD KNOW

REVIEW AND ACCEPTANCE: It is the policy of The American Society of Mechanical Engineers to accept for publication only original contributions to the engineering literature. In most cases, this means that a paper should incorporate substantial new information not previously published. Under certain circumstances, reviews or collations or analyses of information previously published in scattered form may be acceptable. To aid the committee that will review your paper, please complete all items on the 1903 form. Material that is not original must be noted by footnotes and/or bibliography. Receipt of a manuscript by a review committee does not constitute acceptance for presentation and publication by the Society. All manuscripts and author-prepared papers accepted are subject to editing and become the property of the Society. Additional details on the procedure followed in preparation of an ASME paper can be found on [asme.org](http://www.asme.org/pubs/authors) (<http://www.asme.org/pubs/authors>).

APPROVALS AND CLEARANCE: It is the author's responsibility to secure such company approvals as may be required. Government clearance on classified material should be obtained where necessary. If approvals or clearances are involved, the original manuscript should note that these have been obtained. Material not approved should be omitted from the manuscript.

AUTHOR ACKNOWLEDGMENT: It is ASME policy that all those who have participated significantly in the technical aspects of an ASME paper should be recognized as co-authors or cited in the acknowledgments.

USE OF SI UNITS (METRIFICATION): "As of July 1, 1974, SI units (in addition to any other units) will be required in ASME papers and in revised, reaffirmed, and new engineering standards." The foregoing resolution, as recommended by the Metric Study Committee and the Council on Codes and Standards, was voted on and approved by the ASME Council at the 1973 Summer Annual Meeting.

LENGTH: The text of an ASME Transactions paper should not exceed 9000 words or 9 Journal pages.

EXCESS-PAGE CHARGES: Transactions papers: A mandatory page charge of \$200 for each Journal page over 9 will be assessed. Papers will not be published without full payment of excess-page charges. Papers published in printed volumes or on CD-ROMs are not subject to page charges.

VOLUNTARY PAGE CHARGES: Transactions papers: The purpose of the Society is to disseminate technical information of permanent interest resulting in the publication of a series of Transactions quarterlies. Papers of permanent interest having been selected for publication in the ASME Transactions are subject to a Voluntary Page Charge of \$75.00 per page for the first nine pages, which will be invoiced, through the author to the author's company, institution, or agency at the time page proofs are submitted to the author. Publication is not dependent on the payment of the Voluntary Page Charge. Payment of this charge entitles the author to 100 free reprints plus a reduced rate for additional copies ordered in lots of 100.

AUTHOR EXPENSES: The Society does not pay the expenses incurred by authors in connection with the preparation of papers and attendance at meetings to present them, or remuneration to authors for papers published by the Society. Because ASME does not customarily print in four-color, all figures should be designed for reproduction in black and white (e.g., all distinctions to be made must be created through the use of varying degrees of black shading, and/or through the use of textural patterns). If the inclusion of four-color artwork is essential to the publication of a paper, authors must incur the additional charges for printing in four-color. These charges include all color separation, paper, prepress and printing. Authors will be billed the exact amount accumulated in processing their 4-color artwork.

PUBLICATION BY OTHERS: Once a paper has been published by ASME, authors may wish to submit it for inclusion in a non-ASME publication or to incorporate some or all of its elements in another work. Since ASME is the legal holder of copyright for its papers, it will be necessary to secure the permission of the copyright holder to have its material published in another source. In this case, please write to Beth Darchi, ASME Technical Publishing Department, (darchib@asme.org) for permission to have a paper — in whole or in part, as is or adapted — published elsewhere. Each request for permission is considered on an individual basis, and royalty charges may apply.
